## Treasurer's Report:

St. Paul's Actual Budget: There was a projected deficit of \$30,000 but with last year's Grants and Subsidies the updated deficit is \$12,392. Hope for optimistic outlook with an increase in rental. It was asked if the cost of replacing the Peter St. door had been added to the final amount. Eric will ask and find out and let everyone know. The Ramp It Up campaign is standing at \$85,000+. Mary and Doug Daley applied for an Ont. Hydro Grant (\$25,000) on St. Paul's behalf. They included the ramp, Peter St door, and the stairs on the east side of atrium. There will be a 2-3 week period before there is a response to our application. Mission & Service - \$29,000 was raised by St. Paul's.
