Lack of information – what constitutes an indigenous church? Is it less racist to segregate the church's? Intention to respect the Indigenous church as others are supported through the United Church. Is there are provision for formalized way to resolve issues and disputes? 50 years – asking the indigenous community through evolution on how they want to relate to the United church – regionally, and historically. Disagreement/conflict – working through the relationships, adult to adult conversation

2 row wampum belt – two boats going in the same direction but separately.

Language is difficult to understand. Personal work on learning and understanding needs to be done.

Caretakers call – created by the Indigenous Church – UC approved this.

Truth & Reconciliation – UN Document – UC has signed this.

Suggestion: Should we talk to Jody and maybe she can clarify the historical communities of faith, their own developments.
